## MINUTES OF AN ANNUAL MEETING OF MEMBERS

AT NINFA'S RESTAURANT, 14737 MEMORIAL DRIVE

Pursuant to the requirements of Section 3.1 of the Memorial Thicket Homeowners Association, Inc. ("MTHA") By-Laws, an Annual Meeting of Members of MTHA was held at Ninfa's Restaurant, 14737 Memorial Dr., Houston, Texas 77079, on December 2, 2024 at 7:00 p.m., pursuant to written notice to all members of record as of the close of business on November 15, 2024.

Meghan Lee acted as Chair of the meeting and Greg Sergesketter acted as Secretary. The Secretary filed a copy of the Notice of Annual Meeting of Members and the accompanying form of Proxy furnished to the members in MTHA's corporate records book. It was noted that the notice of meeting had been properly mailed to the members representing 159 building lots and that a quorum was present represented in person or by proxy.
